Xiaomi develops 'air charge' tech to power multiple devices

Beijing, Xiaomi on Friday intro-

duced a brand new form of charging called Mi Air Charge Technology that is able to charge devices "within a radius of several metres." Currently, Xiaomi's remote charging technology is capable of 5-watt remote charging for a single device. Apart from that, multiple devices can also be charged at the same time (each device supports 5 watts) and even physical obstacles do not reduce the charging efficiency. "Mi Air Charge Technology enables users to remotely charge electronic devices without any cables or wireless charging stands. Today, we enter a true wireless charging era, Xiaomi said in a statement. In the near future, living room devices will all be built upon a wireless power supdesign, completely free of wires, making our living rooms truly wireless.
