## **Broadcasters wary of TRAI decision** on review pricing

#### New Delhi,

Broadcasters have raised concerns over the Telecom Regulatory Authority of Indias (TRAI) decision to review the issue of pricing, barely eight months after implementing the new tariff order.

They fear that the intrusive approach by the regulator will only discourage and disincentivise fresh investments into the sector, which can have dire consequences. Smaller channels and networks may even face an "existential crisis" in case TRAI implements a fresh pricing model.

TRAI, which noted that the broadcasters have been offering discounts of up to 70 per cent for bouquets compared to a la carte rates causing discrepancies for consumers, has come out with a fresh consultation paper to look into the issue of pricing of channels by broadcasters, cable operators and distribution platforms. However, analysts said that the consultation paper 'Tariff-related issues for broadcasting and cable services' relating to the new tariff order (NTO), which came into force from February 1, did not take into account that consumers across the world opt for bouquets rather than individual channels as the former are cheaper.

### **HK protests: Facebook removes** China-based fake accounts

San Francisco,

Facebook has removed seven Pages, three Groups and five accounts originated in China and involved in posting fake news pertaining to the on-

going protests in Hong Kong.

The individuals behind this campaign engaged in a number of deceptive tactics, including the use of fake accounts — some of which had been already disabled — to manage Pages posing as news organisations, post in Groups, disseminate their con $tent, and also \ drive \ people \ to \ of f-platform \ news \ sites.$ 

"About 15,500 accounts followed one or more of these Pages and about 2,200 accounts joined at least one of these Groups," Nathaniel Gleicher, Head of Cybersecurity Policy at Facebook, said in a blog post late Monday."Although the people behind this activity attempted to conceal their identities, our investigation found links to individuals associated with the Chinese government," he added.Based on a tip shared by Twitter about activity they found on their platform, Facebook conducted an internal investigation into suspected coordinated inauthentic behaviour in the region and identified the malicious accounts. Earlier, users on the social bookmarking website Pinboard slammed China-backed advertisements being run on Twitter, attacking Hong Kong
