## Apple iOS 14.5 to let you set Spotify as default music service

The upcoming Apple iOS update will let users select a third-party default music service like Spotify when they ask to play a song using Siri.

When you ask Siri to play a song on the upcoming iOS 14.5, you would be prompted to select which app you want to use to play it, reports MacRumors.

Apple last week released beta versions of upcoming iOS 14.5 and iPadOS 14.5 updates to developers and public beta testers.

Apple has now added the ability to set a default Apple has now added the ability to set a default music streaming service when using Siri to play songs. First spotted by users on online discussion platform Reddit, Apple will let you ask ?Siri? to play a song in iOS 14.5 from installed third-party music streaming apps in addition to Apple Music. Apple Siri? will also set a music streaming service as the default if you ask it to play from that particular app for the first time. The iOS 14.5 is packed with several such exciting features. You will soon be able to unlock your iPhone with Face ID even when with a Covid-19 mask on, but only if you are wearing an Apple Watch.

In the iOS 14.5 update, Apple Watch will give you haptic feedback to let you know your iPhone has been unlocked.

### Microsoft adding nation-state hacking alerts for enterprises

#### New Delhi,

Microsoft is adding a new security alert to Defender for Office 365 to notify enterprises when their employees are being targeted by nation-state threat actors. The tech giant has been tracking nation-state hacking groups since 2016. The new feature has been added to the Microsoft 365 roadmap website, reports ZDNet. Microsoft Defender for Office 365 is the cloudbased security platform that scans a company's Of-fice 365 accounts for threats. The notification will also appear for system administrators and security teams, who can act swiftly on the attacks. The feature is set to be ready by the end of the month. Microsoft usually notifies around 10,000 users per year of nation-state attacks. "If a user is targeted or compromised in one of these attacks, Microsoft sends them an email about the attack, along with basic advice they need to take to re-secure their inbox and devices", the report said on Monday. In its latest 'Microsoft Digital Defense Report,' the company said that nation-state actors are engaging in new reconnaissance techniques that increase their chances of compromising high-value tar-gets and attackers have developed new ways to scour the internet for systems vulnerable to ransomware.

## Facebook to remove more false alarms about Covid, vaccines

Facebook has announced to expand its efforts to remove false claims on its own platform and Instagram about Covid-19 and its vaccines.

The expanded list of false Covid-19 and vaccinerelated claims that will be removed include: Covid-19 is man-made; vaccines are not effective at preventing the disease they were created to protect against; it's safer to get a disease than to get its vaccine and vaccines are dangerous, toxic, or cause autism, among others. The social network said in a statement late on Monday that the move is taken after consultations with leading health organisations, including the WHO. Starting this week in the US, Facebook will feature links in the Covid-19 Information Center to local ministry of health websites to help people understand whether they're eligible to get vaccinated and how to do so.

by suicide has now sued the stock trading app Robinhood for his wrongful death, the media reported. Last year, Kearns died by suicide in June, as he believed he'd lost \$730,000, and that Robinhood was coming for more than \$170,000 of that money soon. Kearns reportedly tried to contact Robinhood's support department four times, but only got an automated message that he owned the money, reports The Verge.

The day after he died, Robinhood sent another automated message to let him know he didn't actually owe money at all, according to a CBS News report. According to the complaint, Kearns never owed any money at all to Robinhood but the company suggested that he did, sending him an "immediate action required" email telling him he needed to deposit \$178,612.73 by June 17th.

## Vehicle registrations in January falls over **9% YoY**

#### New Delhi,

Vehicle registrations in January 2021 declined 9.66 per cent on a year-on-year (YoY) basis.

On Tuesday, data released by the Féderation of Automobile Dealers Associations (FADA) showed that over 15.92 lakh vehicles were registered January 2021, compared with over 17.63 lakh units in January 2020.

The fall comes after December 2020's registration rose on a YoY basis.

Notably, December's rise was the first positive growth in a month during the current financial year.

At that time, 18.44 lakh vehicles were registered compared with over 16.61 lakh units in December 2019. In January 2021, registration of personal vehicles fell 4.46 per cent on a YoY basis to 2.81 lakh units.
